- Note:**
1. In case a date which is specified for an event happens to be holiday, the event will be carried to the next working day.
  2. All the semester/annual classes will be taken as per the instructions received from Punjab Govt. time to time in this regard.
  - 3\* Two house tests are mandatory for every student, however average of the two shall be counted for awarding the sessional marks. Further, if any student is unable to appear in any of the two house tests due to emergent problem, the college shall conduct the 3<sup>rd</sup> house test with the permission of the Principal and shall conduct the 3<sup>rd</sup> house test one week prior to the semester examination and intimate the students accordingly.
  - 4 In case, a student applies for readmission after the start of the session (before the last date), than it is the responsibility of concerned institute to complete his/her mandatory teaching days as per AICTE/PCI norms.
  - 5 For readmission cases, Principal of the concerned institute shall submit an undertaking (on institute's letter head) that readmission cases of all eligible candidates have been submitted to Board's office before last date and no case of readmission is pending in the institute. (Undertaking format attached).
  - 6 The Board has powers to alter the date of any event if necessary.
  - 7 Date sheet will be uploaded on Board's website 15 days before the start of Exams.
  - 8 Students who have applied for readmission are allowed provisionally to attend the classes till the finalization of readmission cases as per the norms of the Board and they are eligible for the attendance from the date on which he/she submits readmission application form to the Principal of the institute irrespective of the date on which readmission orders received from the Board.
  - 9 For annual courses three house tests should be conducted. (Out of which best two shall be counted for assessment).
  - 10 Communicate the attendance status of each month to students.
  - 11 All the Head of Institutes are instructed that in case of shortfall of classes due to late admissions, the classes would be conducted on Saturdays also to meet the mandatory requirements of minimum teaching days as per the AICTE/PCI norms for the newly admitted students.
